SUMMARY OF THE PROCEEDINGS OF 28th ANNUAL GENERAL MEETING

DATE, TIME AND VENUE OF THE MEETING

The 28th Annual General Meeting of the Company was held on Friday, 2nd 0 September 2022 at 11.30 AM through Video Conferencing.

PROCEEDINGS IN BRIEF

- Mr. Adarsh Purohit, Chairman & Managing Director of the Company occupied 0 the chair.
- Total 13 members including members from Promoter group were present in the 0 meeting.
- 0 As per Section 103 of the Companies Act, 103 the required quorum for convening the AGM was present, accordingly the Chairman called the meeting in order.
- The Chairman informed to the members that the Company is in compliance the 0 requirement of applicable Act and the Rules and the Secretarial Standards made there under with respect to calling, convening and conducting the meeting.
- The Chairman welcomed the Members to the 28th AGM of the Company through 0 Video Conferencing (VC). The Chairman introduced the Directors present and Round Call was taken. He informed that since the meeting was being conducted through VC there was no requirement for proxies. He further informed that the Register of Members, Register of Director's and Key Managerial Personnel and their shareholding, Register of Contracts, etc. were kept open for inspection by Members and the same were accessible in electronic mode to those shareholders who have placed the request for the same.
- With the consent of the Members present the Notice of the 28th AGM and the 0 Auditor's Report were taken as read by the Chairman.
- The Chairman read out the details of remote e-voting and instructions for AGM. 0 He stated that in accordance with the provisions of the Companies Act, 2013, and the rules made thereunder, the remote e-voting facility for voting on the resolution(s) contained in the Notice of the 28th AGM was provided to the Members of the Company from 9.00 am on 30th August 2022 and up to 5.00 pm on 1st September, 2022 and that the e-voting module was closed by NSDL thereafter.

- The following items of business as set out in the notice convening 28th AGM were 0 placed for members' consideration and approval.

RESOLUTION(S)

Ordinary Business:

To receive, consider and adopt the audited Standalone Financial i. Statements of the Company for the financial year ended March 31, 2022 along with the Reports of the Board of Directors and the Auditors thereon.

Special Business:

- Appointment of Mr. Anupam Shrivastava (DIN: 05291844) as an ii. Independent Director of the Company for a period of 5 years.
- Appointment of M/s. Mahato Prabir & Associates, Chartered Accountants, iii. Kolkata (FRN No. 325966E) as Statutory Auditors for a period of 5 years
- The Chairman thereafter informed that the Result of the voting will be declared 0 after counting of votes cast through e-voting during the AGM and votes cast by remote e-voting prior to the AGM as per the report of the Scrutinizer and that the results of the voting will be intimated to the Stock Exchanges and also uploaded on the website of the Company in due course of time.
- The meeting concluded with a vote of thanks to the Chair at 12.15 pm. 0
