
## SUMMARY OF THE PROCEEDINGS OF 27<sup>th</sup> ANNUAL GENERAL MEETING

### DATE, TIME AND VENUE OF THE MEETING

### PROCEEDINGS IN BRIEF

- Mr. Adarsh Purohit, Chairman & Managing Director of the Company occupied the chair.
- Total 11 members including members from Promoter group were present in the meeting.
- As per Section 103 of the Companies Act, 103 the required quorum for convening the AGM was present, accordingly the Chairman called the meeting in order.
- The Chairman informed to the members that the Company is in compliance the requirement of applicable Act and the Rules and the Secretarial Standards made there under with respect to calling, convening and conducting the meeting.
- The Chairman welcomed the Members to the 27<sup>th</sup> AGM of the Company through Video Conferencing (VC). The Chairman introduced the Directors present and Round Call was taken. He informed that since the meeting was being conducted through VC there was no requirement for proxies. He further informed that the Register of Members, Register of Director's and Key Managerial Personnel and their shareholding, Register of Contracts, etc. were kept open for inspection by Members and the same were accessible in electronic mode to those shareholders who shall place request for the same.
- With the consent of the Members present the notice of the 27<sup>th</sup> AGM and the Auditor's Report were taken as read by the Chairman.
- The Chairman read out the details of remote e-voting and instructions for AGM. He stated that in accordance with the provisions of the Companies Act, 2013, and the rules made thereunder, the remote e-voting facility for voting on the resolution(s) contained in the Notice of the 27<sup>th</sup> AGM was provided to the Members of the Company from 9.00 am on 19<sup>th</sup> September 2021 and up to 5.00

- The following items of business as set out in the notice convening 27<sup>th</sup> AGM were placed for members' consideration and approval.


## RESOLUTION(S)
